To allow sufficient time for TTCA processing and nominator's receipt of a Futurity Number prior to making an entry in any Futurity Stakes event, nomination must be submitted no later than 2 weeks prior to the close of entries for such event.

Dogs may be nominated individually if his/her litter would have qualified for nomination in all ways except being past the 4 month litter nomination cut-off.

\*The TTCA member-breeder of the dog being nominated must approve the individual dog nomination and must have been in compliance with all Futurity rules from the time of breeding until present (see TTCA Member-Breeder section below).
